A regular meeting of the Bergen County Board of Social Services was held on August 12, 2014 at 4:30 p.m. in the Board Room of the Bergen County Board of Social Services, 216 Route 17 North, Building A, Rochelle Park, New Jersey.

PUBLIC SESSION:

"Ladies and Gentlemen, the Bergen County Board of Social Services shall now exclude members of the public from the meeting for the following reason:

- 1. The Board shall discuss property matters involving individuals who have received assistance from the Bergen County Board of Social Services. The identification of such individuals or their property may result in a violation of their rights to privacy and may result in the loss of public funds by this agency.
- 2. The Board shall discuss matters which are covered pursuant to N.J.S.A. 10:4-12 (b)(1,2,3) involving individuals who have received assistance from the Bergen County Board of Social Services or who have applied for assistance. To disclose the names of such individuals would work an unwarranted invasion of their rights to privacy.
- 3. The Bergen County Board of Social Services shall discuss personnel matters which are specifically exempt from public meetings pursuant to N.J.S.A. 10:4-12 (b)(8).
- 4. The Board shall discuss matters with Counsel to the Board which matters shall fall within the attorney-client privilege and are therefore excluded from the public meeting.
- 5. The Board may discuss other matters pursuant to N.J.S.A. 10:4-12.

Please be advised that at the conclusion of this session, the Board shall return to a public session and the members of the public are invited to return in order to observe. Thank you.

Acting Director's Report:

(a) Monthly Reports – Statistical & Financial:

A snapshot of caseload and expenditures was provided to the members for the month of June.

(b) Memoranda to the Board

Mr. Morales reported Substance Abuse Initiative and Department of Labor visited the BCBSS and provided training to staff. The state is also going to provide customer service training in September. The agency had one round of customer service training for the front desk and that was very well received. Messrs. Morales and Calocino held voluntary staff meetings on July 24, 2014 to provide information regarding the new building and the move.

Chairman's Report:

Chairman Connelly reported that he toured the new building, and it is taking form.

Committee Reports:

(a) Welfare, Fraud, and Abuse Committee

Freeholder Voss reported from 7/1 to 7/31/14 the agency received Medicaid recoveries in the amount of \$5,289. In July, the agency did not refer any cases to the Prosecutor's Office as the staff was focused on purging files in preparation for the move.

(b) Audit & Budget Committee

No report.

(c) **Building & Grounds Committee**

Mayor Barra reported contrary to the way it looks they are moving along very well and they are on schedule. Mayor Barra advised that he, Mr. Morales and Mike Walters from the Hanson Group met with all the contractors yesterday. The 2nd floor is framed out, sheet rocked, and in pretty good shape. The 5th floor is also in good shape. Effective September 8, 2014 is when staff will be able to take possession of floors 2 and 5. The painters will be coming in about one week to ten days. All the contractors felt we are in good shape. The contractors have been working weekends. The furniture people are ready to start with the installation of cubicles. The 4th floor is still a little dicey but that is the temporary floor for some of the executives' offices. The Mayor expressed he is really impressed with the 2nd floor and that it is going to be good not only for the customers but also for the staff. Staff will be secure. There will virtually never be a time where an employee has to sit in an unsecure space with a customer. The Mayor was impressed by the lack of bullpen look that it has and felt there is less of a sense of a bullpen look in the new building than at the current building. The Mayor advised that Mr. Morales is at the new building every day and he was impressed by everything he knows and that he really knows his stuff. In regard to Freeholder Voss' question regarding how many people the waiting area accommodates and what is done when that area becomes filled, Mr. Morales explained seating will be for approximately 60 which is not different from what we have now. There is the ability to create extra space for approximately 10 to 15 seats if there is a problem. The agency is going to schedule everything after 2:00 p.m. when the part-time staff has left, which will also lessen the waiting room and parking. Mr. Morales discussed the process in which the public will be assisted in the new building.
