A regular meeting of the Bergen County Board of Social Services was held on September 2, 2014 at 4:30 p.m. in the Board Room of the Bergen County Board of Social Services, 216 Route 17 North, Building A, Rochelle Park, New Jersey.

PUBLIC SESSION:

John L. Schettino, Esq., called the meeting to order. General Counsel read the notice required by the Open Public Meetings Act as follows:

- 2. The Board shall discuss matters which are covered pursuant to N.J.S.A. 10:4-12 (b)(1,2,3) involving individuals who have received assistance from the Bergen County Board of Social Services or who have applied for assistance. To disclose the names of such individuals would work an unwarranted invasion of their rights to privacy.
- 3. The Bergen County Board of Social Services shall discuss personnel matters which are specifically exempt from public meetings pursuant to N.J.S.A. 10:4-12 (b)(8).
- 4. The Board shall discuss matters with Counsel to the Board which matters shall fall within the attorney-client privilege and are therefore excluded from the public meeting.
- 5. The Board may discuss other matters pursuant to N.J.S.A. 10:4-12.

Please be advised that at the conclusion of this session, the Board shall return to a public session and the members of the public are invited to return in order to observe. Thank you.

Acting Director's Report:

(a) Monthly Reports – Statistical & Financial:

A snapshot of caseload and expenditures was provided to the members for the month of July. In regard to a weekly report that is submitted to the state for SNAP, as of the last report, the agency's timeliness is above what is expected. The state was extremely complimentary of the work the agency has done to increase the timeliness rate. A discussion followed.

John Ensslin, a reporter with The Record newspaper, was present in the public seating area during the meeting.

For the record, Freeholder Voss arrived at approximately 4:44 p.m.

(b) Memoranda to the Board

Mr. Morales discussed the Board directed that the agency dispose of furniture. Several municipalities came, went through, and selected furniture that they wanted. The agency will hold a public action for the remainder furniture, which will be published in the newspaper on 9/04/14 and 9/11/14. The state contacted the agency regarding the backlog of Medicaid applications that exist. They offered to take them off of the agency's hands and have the vendor process them. The advantages to this are the clients will get service faster than we are able to provide them with. We do have some retooling to do in that department, and we can do that retooling better without the pressure of having a big backlog of applications. Additionally, they will not only determine eligibility. In most cases, they will also handle the redeterminations. In theory, we are losing funding but in reality we are saving the taxpayers of Bergen County having to fund 50% of additional staff members to pay for the processing of this service. With the Chairman's approval, we are currently in the process of transferring that backlog to the state.

For the record, Freeholder Zur arrived at approximately 4:50 p.m.

Mr. Morales talked about the state's vendor, Xerox, who processes thousands of cases on a monthly basis. In response to Freeholder Zur's inquiry regarding the state's turnaround time, Mr. Morales will get information from the state regarding how long they expect it to take for Xerox to process the pending Medicaid applications that are being transferred to them.

Chairman's Report:

Chairman Connelly reported he toured the new building, and it is way ahead of where it was two weeks ago.

(c) Building & Grounds Committee

Mayor Barra reported that he toured the new building with the press today. They are making great strides. The 5th floor is virtually ready. All of the furniture was unloaded this morning by a couple of tractor trailers and they are going to start installing it tomorrow on the 5th floor. The 2nd floor is in pretty good shape. Probably a week or so it will be just about ready for final coats of paint. The 4th floor is going to be temporary space. Mayor Barra commented Alex Morales has been a tremendous asset. He is at the new building multiple times during the day, and the agency saved money by not having a construction manager on site. Mayor Barra expressed he is particularly impressed with the 2nd floor. The security will be increased dramatically with the staff. A display will be put up in the waiting area for any clients interested in seeing what the new building looks like. There is one minor issue on the lease, which will be discussed in Closed Session.

In regard to the issue with the reimbursement of legal fees, Mr. Morales received a written response from Mr. Wielkotz. Mr. Wielkotz advised that the BCBSS should go back to the funding sources and request approval to utilize it in the manner as suggested. With the Board's approval, Mr. Morales will get a letter out to the funding sources and request approval, which includes the county and the state. Mr. Carbone discussed since the agency is going to have a much larger pool of money he wants to go back and ask him can we initially use the money we have or commitment to that back scanning process and eventually refund the monies to other funding sources in the federal government when we get the other money. Rather than taking the pool we have now and dividing it one third/two thirds, utilize the full pool we have and reimburse the federal government from the other monies that we will get later on. Mr. Morales will speak with Mr. Carbone and forward on this written request to the Auditor.
