A regular meeting of the Bergen County Board of Social Services was held on September 6, 2016 at 4:30 p.m. in the 4'th Floor Board Room of the Bergen County Board of Social Services, 218 Route 17 North, Rochelle Park, New Jersey.

PUBLIC SESSION:

John L. Schettino, Esq., called the meeting to order. General Counsel read the notice required by the Open Public Meetings Act as follows:

"Pursuant to the Open Public Meetings Act, adequate notice of the meeting scheduled for September 6, 2016 has been provided in the following manner:

- 1. By a prominent posting of the schedule of meetings for 2016, including a notice of the scheduled time, scheduled date, and location of this meeting at the Bergen County Administrative Building, One Bergen County Plaza, Hackensack, New Jersey.
- 2. The mailing of this notice of the time, date, and location of this meeting to "The Record", which was published on December 6, 2015 and to the Herald News, which was published on December 6, 2015.

3. By filing of the notice of the time, date, and location of this meeting with the Bergen County Clerk, said filing having taken place on December 3, 2015.

The notice required by the "Open Public Meeting Act" was read as follows:

"Ladies and Gentlemen, the Bergen County Board of Social Services shall now exclude members of the public from the meeting for the following reason:

- 1. The Board shall discuss property matters involving individuals who have received assistance from the Bergen County Board of Social Services. The identification of such individuals or their property may result in a violation of their rights to privacy and may result in the loss of public funds by this agency.
- 2. The Board shall discuss matters which are covered pursuant to N.J.S.A. 10:4-12 (b)(1,2,3) involving individuals who have received assistance from the Bergen County Board of Social Services or who have applied for assistance. To disclose the names of such individuals would work an unwarranted invasion of their rights to privacy.
- 3. The Bergen County Board of Social Services shall discuss personnel matters which are specifically exempt from public meetings pursuant to N.J.S.A. 10:4-12 (b)(8).
- 4. The Board shall discuss matters with Counsel to the Board which matters shall fall within the attorney-client privilege and are therefore excluded from the public meeting.
- 5. The Board may discuss other matters pursuant to N.J.S.A. 10:4-12.

Please be advised that at the conclusion of this session, the Board shall return to a public session and the members of the public are invited to return in order to observe. Thank you.

Maria Aberasturi – Teaneck, NJ

Ms. Aberasturi, an employee of the Bergen County Board of Social Services, discussed the County has scheduled its 5th Elder Abuse Awareness Conference on October 14, 2016 at the Law and Public Safety Institute located at 281 Campgaw Road in Mahwah, N.J. They are going to present a Case Study and will be offering C.E.U.'s for Social Workers and C.L.E's for attorneys. The application can be found on Bergen County's website. Prosecutor Paul Greenwood, Esq., from San Diego DA's Office who has been very successful in prosecuting crimes against the elderly will be a speaker at this conference. Ms. Aberasturi encouraged Board Members to attend. In regard to Adult Protective Services, Ms. Aberasturi asked the Board to consider obtaining another agency vehicle for staff and interns to use for agency business.

For the record, Freeholder Zur arrived at approximately 4:40 p.m.

The Board expressed the need to look into the policy in regard to interns using agency vehicles. At the Board's request, the Acting Director will contact the agency's insurance carrier and look into this matter and report back to the Board.

Sabrina Torres – Clerk

Ms. Torres, an employee of the Bergen County Board of Social Services, read a statement. She discussed that she spoke at the July Board Meeting to make everyone aware of some ongoing

issues such as the agency undermining the Civil Service Commission and the retaliatory culture that has been trending at the agency. She expressed that not only have her concerns gone unanswered, but she is further being retaliated against by the agency. As a result of the statements that she made at the July Board Meeting, the agency has now begun to watch and stalk her.

Chairman Connelly responded to Ms. Torres. He advised that the Board has done something about her concerns. He told her that an individual is present at this afternoon's Board Meeting to present his report regarding an investigation to the Board Members, which will take place in Closed Session.

Janet Chiong-Morillo & Marco Morillo – Hackensack, NJ

Ms. Chiong-Morillo, an employee of the Bergen County Board of Social Services, read a statement. She discussed taking a later lunch to pick up her children from school. Ms. Chiong-Morillo advised the Board that she took the proper channels to resolve this issue and is only asking for an accommodation, which has been denied. She asked the Board to help her family.

Bill Oserin – Englewood, NJ

Mr. Oserin, an employee of the Bergen County Board of Social Services, discussed that he needed a car two weeks ago to address a domestic violence issue. He explained that one of the two agency cars was not available, and was told that he could not use the second available car to transport this individual to a complex. It was suggested that he use his own car. Mr. Oserin expressed the need for additional agency vehicles for staff.

In regard to agency vehicles, the Board expressed they need to have a dialogue as far as direction and services that the Board is going to be providing and have a report come to the Board as far as the service that is necessary and if this is something that they should be doing as part of the agency and then make a Board decision. The Board discussed that a policy should be developed. After the Board has a cost analysis in front of them, they could determine how they want to proceed. General Counsel clarified that this agency needs to review and find out what the needs are, the frequency, and how this agency could address that need. It was suggested that the Bergen County Board of Social Services find out from other agency's how they handle this situation. If there is a policy, it will be revisited by management. This item will be revisited once management provides a report to the Board.

Ed Austeri – Human Service Specialist 2

Mr. Austeri, an employee of the Bergen County Board of Social Services, discussed the low morale in the agency. He expressed his displeasure with Administration not providing explanations to individuals that do not get hired.

Chairman Connelly responded to Mr. Austeri. He advised that in the real world companies do not provide explanations to individuals that do not get a job.

Dolores Phillips - Montvale, NJ

Ms. Phillips, an employee of the Bergen County Board of Social Services, discussed she is scheduled to represent the agency at a Senior Picnic at Van Saun Park on September 14, 2016. She reported that our agency is the only group that has no giveaways. She wanted to know why the Bergen County Board of Social Services can't also provide giveaways to the seniors. Ms. Phillips discussed that she recently attended and represented the agency at a Health Fair in Hackensack. She reported that she was embarrassed to be there and represent the agency because she was given a couple of outdated pieces of paper to distribute to people and a sign that was falling down that the Church tried to assist her with. She expressed the process should be better in addition to a piece of candy. There should be some form of information that the agency could give out to the public explaining the wonderful things that the Bergen County Board of Social Services does. Mayor Barra volunteered to coordinate and meet with Administration and whoever else to do some kind of brochure or handout.
