Sue Silverstein – Fair Lawn, NJ

Ms. Silverstein, Training Supervisor, discussed a problem with the Fair Hearing process. The agency holds Fair Hearings on Tuesdays and Thursdays. Currently, the agency is using the Tax Court on Tuesdays and that is working out very well. However, they do not have a room on Thursdays. Ms. Silverstein advised that on Thursdays, staff and clients must travel to Newark for Fair Hearings, which is inconvenient for the clients getting there and expensive for the staff. Maria Aberasturi – Teaneck, NJ

Ms. Aberasturi discussed retirees have their Medicare payments reimbursed to them. A retiree brought to her attention they did not get a check in January and did not receive any notice regarding any change. The response they received is the reason they haven't received their checks is because the Board is conducting a legal review based on state regulations regarding the reimbursement of the Medicare. In addition, she discussed it is unclear what the chain of command is at the Bergen County Board of Social Services.

Ronda Wilson – Hackensack, NJ

Ms. Wilson inquired about the chain of command at the Bergen County Board of Social Services.

Diane Baillif - Hasbrouck Heights, NJ

Ms. Baillif provided a follow-up to last month's discussion regarding transportation. She and a supervisor of the Work First Unit met with the One Stop Career Center and they removed 56 people from the following list of people to get transportation reimbursement. This past month they removed another 45 people. They have taken off close to 100 people.

(b) <u>Update on Management Review Audit (Bob Calocino)</u>

The Acting Director reported that he contacted the Division of Family Development and requested a Management Audit.

(c) Memoranda to the Board (Alex Morales)

Mr. Morales reported that a team has been established to look at how the agency services phone calls and create and implement improvements as appropriate. A second group is going to start doing Customer Service Initiatives, which is sort of like an ambassador type program to assist clients in understanding and complying to help navigate the system. They are trying to get some volunteer retirees to come back and assist customers with this initiative. A separate group is working on some additional tools so they can transfer some of the tasks from the case workers to the clerical staff and to work on a consolidated appointment system so that the appointments can be changed at the front rather than interrupting the case worker. He is creating a case notes tab so when a call is placed the person receiving the phone call will be able to provide information. Currently, he is working on a resource section with information from all around the County that offers social services made available to the public in the reception areas. He met with the Homeless Shelter and the Bergen County Housing Authority who are interested in pursuing a similar strategy for homeless families. He advised that they will be visiting Mercer County who has a nationally recognized program for family homelessness. For this, he will be requesting the support of the Freeholders in the near future. He discussed the building and distributed a memorandum to the Board. A discussion ensued regarding the log of turning away people at the front desk. Mr. Morales discovered that between December 13th through January 31st, 934 applicants who came in requesting an interview were turned away. Mr. Morales is looking at ways to change the application process to try to eliminate turn aways. Beginning tomorrow, Mr. Morales advised that there will be a log documenting name and

contact information for customers turned away at the front desk.

(c) Building & Grounds Committee

Mayor Barra made some comments that he considered to be some misstatements that were made during the Open Session at last month's meeting. This committee was put together about nine to twelve months ago to look for a new location for this agency. They have explored every possible avenue. They are looking at this building and other buildings. Their main focus is the location primarily for the clients but also for staff. The other criteria is the manner in which they will structure and organize the space and how the agency can work most efficiently for the staff and for the clients. Comments were made that they are not utilizing Bergen County's assets in terms of information and that is simply not accurate. They have retained the services of a real estate firm. They did that in a very detailed process whereby, they interviewed various firms that wanted to participate. They obtained RFQs from them and interviewed them very extensively. They were narrowed down to second interviews and the Hanson firm was retained because of their knowledge locally with real estate, particularly in Hackensack. Another reason why they retained them, which is

very significant, was that the commission paid to Hanson will be paid by whoever the ultimate landlord will be and will be paid by the landlord whenever the lease is negotiated. The most important thing that Hanson agreed to provide them with was an architect and space planning firm who will do the space planning and architecture for the new facility. This is critical to the staff and to how we are going to intake our clients, how we send them, where we send them, security, etc. Security is a major issue that the staff and the Board have been concerned about. DMR is a firm that has already done a Board of Social Services so they have been through this already. The committee has gone to that location, as well as, other agencies who are dealing with the same services that we provide. They looked at their security, intake procedures, etc. The bottom line is this committee has been working tirelessly to find the best place for everyone involved. They do intend to have the input of the staff because the input of the staff is critical both in terms of space planning and location however, they are not there yet. There is roughly about 16 to 18 months. They have already looked at several locations but none that they thought were the place for us. When the time is right, they will bring the staff in to tell them what they are looking at and to get their ideas. A survey has already been started that is going out to staff in terms of what they need, the amount of space that they need, and where that space will fit within the confines of the overall structure of the organization. This is what the committee has been doing and they are going to continue their efforts. There are several meetings coming up over the next few days and when the time is right the staff will be brought into the picture. First, the department heads and then the individual staff to get their input so that they can put together what everyone wants, which is what is best for the agency and what is best for the clients. Mayor Barra discussed people need to understand what they are doing is for the staff and clients.
