#### Chairman's Report

Chairman William E. Connelly welcomed Sue Silverstein as a new Member of the Board.

# **Administration Report:**

#### (a) Monthly Reports – Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packet.

In the month of February, the agency took 2,510 new applications and staff processed 7,803 actions. Also in February, the agency served 4,590 customers in our lobby. The TANF (Temporary Assistance to Needy Families) caseload increased by 7 cases and compared to one year ago the caseload went down cumulative by 23 cases, SNAP (Supplemental Nutrition Assistance Program) caseload decreased by 47 cases and compared to one year ago the caseload went down cumulative by 817 cases, GA (General Assistance) caseload decreased by 12 cases and compared to one year ago the caseload went down cumulative by 127 cases. Adina Yacoub explained that in regard to Medicaid, there is a new way in reporting. We are no longer reporting Medicaid caseload and/or households. It is now done by recipients/individuals. This is how the state is handling this now, which is called shared data warehouse reporting. This is the first time we are doing this so there is nothing to compare this with. For this month, the agency has 41,296 individuals on Medicaid. That includes Family Care, Medicaid for nursing homes, and the aged and disabled in the community (ABD).

# (b) Memoranda to the Board

As a fundraiser, the agency collected \$790 for the Children's Heart Foundation. The agency is offering advanced customer service training for 75 employees, which will take place on March 24 and March 25, 2020. The Memorandum of Understanding between the Board and the DMAHS is being discussed. The more we discuss the more problematic this becomes. We discovered that even if you are 95% timely, if you have one redetermination that is overdue for 24 months or longer, then you lose all your incentive money. The Executive Committee of the Directors' Association is meeting on March 6<sup>th</sup> with the Director of DMAHS to discuss this and a host of other issues with the MOU. Administration met with representatives of Rockland Electric on February 21, 2020. They were referred to us by the County Executive's office. We discussed how we could get the word out to our clients on a \$2,500 benefit that is available for them to use for energy saving appliances or air-sealing and insulation. Administrator Mr. Larobardier did further research and put a packet together for our supervisors to help them assist customers with these needs. On February 20, 2020, Adina Yacoub attended County Executive Tedesco's State of the County address to represent our agency. On February 26 through February 28, 2020, Adina Yacoub attended the Child Support Convention with other Directors and child support staff from all the counties. They attended workshops and listened to the DHS Commissioner and other important speakers. Adina Yacoub attended some leadership classes as well. On February 12, 2020, with the concerns over COVID-19, Administration sent an email to all staff with instructions from the CDC on information and preventive measures regarding the virus. Administration made sure that all departments and kitchen areas on the three floors have big bottles of hand sanitizers. Today, Administration contacted our cleaning company to provide extra care for those areas where there is hand touching. We asked that they sanitize door knobs, key pads, and other commonly used surfaces. We received notice from Acrisure (our insurance consultant) regarding a new mandate for commuter benefits. Mr. Stahlmann contacted AFLAC who are working on expanding our existing Flex plan. Our Payroll Department contacted the County regarding the ICON payroll system accommodating this new benefit. This benefit is available to those who use buses and trains to commute to work.
