Administration Report:

(a) Monthly Reports - Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload increased from 241 to 242 and is up by 1 case and compared to one year ago it went up 2 cases, SNAP (Supplemental Nutrition Assistance Program) caseload decreased from 23,765 to 23,095 and decreased by 670 cases from last month and compared to one year ago it went up by 1,753 cases, GA (General Assistance) caseload increased from 414 to 428 cases up by 14, and compared to one year ago it went down by 47 cases, and Medicaid individuals decreased from 47,445 to 46,733 down by 712 individuals.

Burial stats are as follows: 24 inquires, 25 approved, and 4 denials. The agency paid out \$53,503 and recovered \$1,544.59.

In January 2022, the agency received 1,659 applications for cash and SNAP applications and 1,371 Medicaid applications for a total of 3,030. In February 2022, the agency received 1,400 applications for cash and SNAP applications and 1,067 Medicaid applications for a total of 2,467.

In the month of February, our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 17 individuals/families in motels. We have 15 families in the

HEARTS Program, 6 in the Emergency Shelter, and 9 in TANF/Bridge side. We have 9 families placed at the Center for Hope and Safety (DV shelter). We had 66 Emergency Assistance applications and 108 clients on Temporary Rental Assistance. We had 12 placements as referrals from 211. We have 254 active DDD cases. The Adult Protective Service (APS) Unit received and processed 84 referrals and currently have 26 open cases.

(b) Memoranda to the Board

Scott Modery reported that the agency reopened to the public on Tuesday, February 22, 2022. We continue to advertise the online or paper application process to prevent an in-person trip. Our in-person services were pared down to promote quick client service, minimizing client time spent within the agency. We expanded the capabilities of our queue system so clients can wait outside and receive a text when their appointment time has arrived. A mediation session attended by the negotiating committee and CWA Local 1031 was held on Friday, February 25, 2022. Mediation with CWA Local 1089 is scheduled to be held on Thursday, March 3, 2022. We onboarded 11 employees this month with 6 currently in training. We met with the Bergen County Jobs Center to discuss the reinstitution of work activities in conjunction with TANF and General Assistance. The Jobs Center will be welcoming clients again as these programs begin to return to compliance requirements. This return to compliance requires significant catch up since there are many clients to see and the capacity of the Jobs Center has been reduced to promote social distancing. On February 8, 2022 we had a vendor demonstrate a product which would allow us to send text reminders to our clients regarding deadlines and other communications. We are currently evaluating whether this product would be beneficial to us and can integrate with our systems. We were notified on February 17, 2022 that the NJ Child Support Council has named Bergen County as the winner of the CWA Office of the year for 2021. Scott Modery recognized and congratulated Michael Sluka, Esq., Suzan Kirieakes, and each member of our Child Support & Paternity Unit for a job well done. Adina Yacoub, Scott Modery, Michael Sluka, Esq., and Suzan Kirieakes prepared a thank you video to the council which will be presented at the annual Child Support Conference. As a token of appreciation and recognition of this high honor, Adina Yacoub provided a pizza luncheon to the department. On February 22, 2022 Michael Sluka, Esq. and Sonia Aufiero gave a presentation to Human Services Advisory Council (HSAC) attendees on the Adult Protective Service (APS) program and how the Bergen County Board of Social Services handles various scenarios to assist this vulnerable population. They concluded the presentation by answering questions and the presentation was very well received. On February 22, 2022, Scott Modery met with the Audit and Budget committee to present the agency's proposed budget. He joined in multiple meetings involving County and State participants this month including the County Welfare Directors' Association, Human Services Advisory Council, and the Workforce Development Board. In all these meetings the participants echoed that Adina Yacoub is going to be highly missed. Our current security guard contract expires on March 8, 2022 and we will be welcoming our new vendor on March 9, 2022. On February 10, 2022, Scott Modery met with the President of AEGIS Security and he toured our site. He explained our process to him to make the upcoming transition as smooth as possible. We received a thank you letter from the Honorable Bergen County Executive James J. Tedesco III for making the 16th annual Project Homeless Connect (PHC) - Point-in-Time (PIT) an outstanding event. The Bergen County Board of Social Services donated \$470.00 in Shop Rite & Dunkin Donut gift cards to benefit our vulnerable population in Bergen County.

Chairman's Report

Chairman William E. Connelly welcomed and congratulated Scott Modery in his new role as Acting Director.

Committee Reports:

(a) Welfare, Fraud, and Abuse Committee

Yris Encarnacion reported from February 1 to February 28, 2022 the agency received Medicaid recoveries in the amount of \$6,630.87 and the year-to-date 2022 is \$25,672.28. No new cases were referred to the Prosecutor's office during the month of February.

(b) Audit & Budget Committee

Erin N. Delaney reported that she and Randi Duffie had a Budget Committee meeting with Adina Yacoub, Scott Modery, and Geraldine Nestrowitz on February 22, 2022. There was discussion about significant increases in health benefit costs this year, particularly for retirees. Helping to offset a portion of this increase in 2022 was a last-minute allocation of SNAP pandemic funding received in the final days of 2021, which could be carried into 2022. The budget for 2022 is increased by 2.23% over 2021. While 2% is generally the target percentage, the Board initiated a change to the process in which Medicare Part B reimbursements were issued to retirees last year. This allowed for a one-time savings, which will not be realized this year. The County was made aware of this at the budget hearing in 2021 and was notified because of this that there could be a larger than normal increase in 2022.
