Administration Report:

(a) Monthly Reports – Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload increased from 245 to 261 and is up by 16 cases and compared to one year ago it went up 21 cases, SNAP (Supplemental Nutrition Assistance Program) caseload decreased from 22,533 to 22,188 and decreased by 345 cases from last month and compared to one year ago it went up by 97 cases, GA (General Assistance) caseload increased from 424 to 456 cases up by 32, and compared to one year ago it went up by 12 cases, and Medicaid individuals decreased from 45,722 to 45,158 down by 564 individuals.

Burial stats are as follows: 17 inquires, 19 approved, and 2 denials. The agency paid out \$77,152.00 and recovered \$1,337.63.

In March 2022, the agency received 1,688 applications for cash and SNAP applications and 1,199 Medicaid applications for a total of 2,887. In April 2022, the agency received 1,453 applications for cash and SNAP applications and 1,134 Medicaid applications for a total of 2,587.

In the month of April, our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 10 individuals/families in motels. We have 15 families in the HEARTS Program, 4 in the Emergency Shelter, and 11 in TANF/Bridge side. We have 15 families placed at the Center for Hope and Safety (DV shelter). We had 93 Emergency Assistance applications and

115 clients on Temporary Rental Assistance. We had 17 placements as referrals from 211. We have 262 active DDD cases. The Adult Protective Service (APS) Unit received 106 referrals and currently have 21 open cases.

(b) Memoranda to the Board

Scott Modery reported that he attended a meeting on April 6, 2022 which involved multiple NJ Social Service agency Directors along with the Robert Wood Johnson Foundation. The foundation's initiative is to assess the landscape of hunger in New Jersey. They are working with the Food Research & Action Center (FRAC) and are seeking ideas from New Jersey Social Services agencies to design a plan with the goal of reducing food insecurity in New Jersey. This interaction was further discussed at the Directors' meeting on April 9, 2022 where several ideas were proposed to bring back to the foundation. On May 5, 2022 we will be sending representation to the town of Glen Rock, which will be hosting a Senior Fest. On April 9, 2022 we sent representatives to the Veterans Resource Fair at Bergen Community College. The fair was attended by Bergen, Sussex, Warren, and Passaic officials. We will be sending representation from our Adult Protective Services (APS) staff to the Bergen County Caregiver Conference on April 30, 2022 at One Bergen County Plaza. This conference is attended by the County Executive and will touch on many topics including legal considerations for caregivers, Alzheimer's Disease, and self-care for the caregiver. On May 12, 2022, Mr. Modery will be attending the Division of Senior Services' annual Public Hearing on the Needs of Older Adults along with our APS Administrator. The hearing is a major forum to gather information on the needs and concerns of Bergen's seniors. The Federal public health emergency is scheduled to end on July 15, 2022. Accompanying this end will be the "unwinding" process. This represents the single largest redetermination exercise in the history of New Jersey's Medicaid program where every case will need to be redetermined within a twelve-month timeframe. Since, the total membership of NJ FamilyCare has increased by about 25% since the beginning of the PHE and no cases were closed during the PHE this volume will place an extreme burden on staffing levels across the State which are not designed with this quantity of cases in mind. Maintaining timeliness and the challenges that this unwinding is presenting has been an ongoing discussion across the State. The agency has now returned to pre-pandemic operations as it pertains to clients. While some waivers still exist which do not necessitate client visits to the agency, we have reopened our visitor floor and are allowing entry for any client who wishes to do business personally. On April 28, 2022 CWA 1089 held a demonstration outside the building during lunch Northjersey.com published an article and pictures on 4/29/2022 describing the hours. demonstration.
