Administration Report:

(a) Monthly Reports - Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload increased from 259 to 261 from last month and compared to one year ago it went up 34 cases, SNAP (Supplemental Nutrition Assistance Program) caseload decreased from 22,210 to 21,811 and decreased by 399 cases from last month and compared to one year ago it went down by 1,022 cases, GA (General Assistance) caseload increased from 484 to 507 cases up by 23, and compared to one year ago it went up by 87 cases, and Medicaid individuals increased from 57,165 to 57,276 up by 111 individuals.

Burial stats are as follows: 17 inquires, 25 approved, and 1 denial. The agency paid out \$80,324.00 and recovered \$1,180.36.

In August 2022, the agency received 1,636 applications for cash and SNAP applications and 1,323 Medicaid applications for a total of 2,959. In July 2022, the agency received 1,561 applications for cash and SNAP applications and 1,179 Medicaid applications for a total of 2,740.

In July, our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 10 individuals/families in motels. We have 20 families in the HEARTS Program, 11 in the Emergency Shelter, and 9 in TANF/Bridge side. We have 8 families placed at the Center for Hope and Safety (DV shelter). We had 80 Emergency Assistance applications and 127 clients on Temporary Rental Assistance. We had 17 placements as referrals from 211. We have 260 active DDD cases. The Adult Protective Service (APS) Unit received 81 referrals and currently have 24 open cases.

(b) Memoranda to the Board

Scott Modery reported that our yearly financial audit has begun. The audit is primarily remote as we collect documents and upload through the auditor's web portal. Certain original or cumbersome documentation will require in person review and will take place on an "as needed" basis. The recent medical emergency onsite has reminded us that it is best to be prepared. With that in mind we are pricing Automated External Defibrillator (AED) training for all interested staff. We currently have three AEDs onsite and want to ensure that should the need arise, there are staff trained to use the device. Our SNAP Administrator Yvonne Jordan and Scott Modery had a conference call with Lisa Martin from City Green on July 12th. City Green receives a mixture of private donation and public funding to expand accessibility for SNAP recipients by offering discounts on fruits and vegetables at designated locations. We will be displaying program information onsite and have requested information to present on our website. We were recently notified that we would receive \$255,414 SNAP American Rescue Plan Act (ARPA) Administrative funding. This money is being provided to County Welfare Agencies in varying amounts by County and must be used for SNAP related processes. We have been funding overtime with this money to ensure all SNAP cases are 100% current. There is no County match on these dollars and any unspent balance expires on 9/30/2022. The building is currently in the process of constructing two additional tenant offices. With these spaces filled and the knowledge that both new tenants will have a visitor base, Scott Modery is in constant communication with the building manager to monitor day to day circumstances as it relates to traffic and parking difficulties. We are working to prevent a repeat of the complications, which were the norm when we moved in.
