Administration Report:

(a) Monthly Reports – Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for September was 325 cases, August was 306 cases and compared to one year ago it went up 105 cases, SNAP (Supplemental Nutrition Assistance Program) caseload for September was 21,757 and August was 21,944 and compared to one year ago it went up by 499 cases, GA (General Assistance) caseload for September 408 cases and August was 384 cases and compared to one year

ago it went up by 11 cases. In regard to Medicaid, there were 58,173 individuals in September and 57,839 in August an increase of 334 individuals.

Burial stats are as follows: 21 inquires, 27 approved, and 0 denials. The agency paid out \$76,064.56 and recovered \$2,143.89.

In September 2022, the agency received 1,670 applications for cash and SNAP applications and 1,251 Medicaid applications for a total of 2,921. In August 2022, the agency received 1,820 applications for cash and SNAP applications and 1,439 Medicaid applications for a total of 3,259.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 5 individuals/families in motels. We have 16 families in the HEARTS Program, 13 in the Emergency Shelter, and 3 in TANF/Bridge side. We have 12 families placed at the Center for Hope and Safety (DV shelter). We had 104 Emergency Assistance applications and 120 clients on Temporary Rental Assistance. We had 25 placements as referrals from 211. We have 257 active DDD cases. The Adult Protective Service (APS) Unit received 35 referrals and currently have 33 open cases.

A discussion ensued regarding SNAP benefits and those who quality are still getting the maximum allowance. In regard to the recertification process, the agency is seeing a lot of customers who never had to deal with recertifying and they are ignoring our letters and paperwork, which then causes the case to close and then they come into the office after the case closes and it generates a lot of extra work for the staff. Scott Modery indicated this is what you do not see in the caseload because there is so much going on in applications that may never ever make it to cases and sometimes it requires double work before they become cases.

Alexandra Harwin, Esq. asked if there is any ability to bring on more personnel this year or if this is something that has to happen next year. Scott Modery indicated that this year we are hiring. We are up against a few challenges and are seeing more resignations and turnover than we have in a long time. We are having some difficulty getting some people. We are running at our maximum number for the budget this year. Next year, we will be looking to increase that.

Scott Modery reported that this month, we are seeking approval to move some parttime positions to full-time positions. The goal is to decrease the amount of part timers in the upcoming year.

(b) Memoranda to the Board

Scott Modery reported that staff attended the Fall Caregivers Conference sponsored by the Department of Human Services/Division of Senior Services on October 20, 2022 at 1 Bergen County Plaza in Hackensack. We employed Lifesavers Inc. to do six two-hour sessions of AED (Automated External Defibrillator), CPR (Cardio Pulmonary Resuscitation), and choking training for any employee who expressed an interest. 110 employees took the course and have received their

CPR certification. This certification lasts for two years. CWA 1089 demonstrated on 10/20/2022 and again on 10/27/2022 in front of the building. This demonstration was to call attention to the 24%+ increase in healthcare premiums and corresponding increase in employee contributions. The Adopt-a-Family and Adopt-an-Individual project is underway. Anyone can adopt a family or individual by purchasing gifts from holiday wish lists. Wrapped and labeled gifts will be accepted and the deadline to bring the gifts is no later than December 14, 2022. All wrapped and labeled gifts can be brought to Administration located on the 4th floor. On October 26, 2022, Administration met with a Korean delegation of 18 members of the Ministry of Health and Welfare and presented our processes and procedures for administering various assistance programs. The delegation asked many questions which were answered in detail and they were very grateful for the time allotted to them to learn about our procedures.

In regard to the Adopt-a-Family and Adopt an Individual project, Susan Silverstein reported that she started volunteering to help with this project. She announced if anyone wanted to adopt a family they could see her after the Board Meeting.

Alexandra Harwin, Esq. reported from October 1 to October 31, 2022 the agency received Medicaid recoveries in the amount of \$19,205.87 and the year-to-date 2022 is \$148,204.99. No new cases were referred to the Prosecutor's office during the month of October.

A discussion ensued regarding fraud. Scott Modery explained that the agency sends out letters to customers to pay back monies and if they are on a program the agency reduces their assistance by a certain amount each month and sometimes monies are even withheld from income tax returns.

The Board expressed interest in having the supervisor from the Fraud Department come and speak to the Board in the New Year.
