Geri Nestrowitz, Supervising Accountant, provided the Treasurer's Report this afternoon. She mentioned that everyone should be looking at a revised Bill's List & Schedule of Vouchers. In regard to the revised Bill's List, Ms. Nestrowitz pointed out \$2,224 made payable to Scott Modery. She explained that expense was for the agency's Log Me In subscription that ended approximately two months ago. The charge was put on Mr. Modery's credit card to get the subscription back up and running. Mr. Modery explained that the company sent renewal notices to the agency's IT supervisor who retired at the end of last year. As a result, we were not getting the renewal notices and they shut off the service. The agency has outstation and HEARTS staff that use this service so we had to get it back up and running as quick as possible. Scott Modery mentioned that prior to proceeding he spoke with the Chairman about this item.

Administration Report:

(a) Monthly Reports – Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for June 2023 was 369 and May 2023 was 385 cases, and compared to one year ago it went up 108 cases, SNAP (Supplemental Nutrition Assistance Program) caseload for June was 22,693 and May was 22,758 and compared to one year ago it went up by 882 cases, GA (General Assistance) caseload for June was 402 and May was 421 cases and compared to one year ago it went down by 105 cases. In regard to Medicaid, there were 60,293 individuals in June and in May 2023 there were 61,043 individuals a decrease of 750 individuals.

Burial stats are as follows: 21 inquires, 21 approved, and 0 denials. The agency paid out \$113,965.00 and recovered \$1,740.03.

In June 2023, the agency received 1,540 applications for cash and SNAP applications and 1,295 Medicaid applications for a total of 2,835. In May 2023, the agency received 1,570 applications for cash and SNAP applications and 1,448 Medicaid applications for a total of 3,018.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 5 individuals/families in motels. We have 25 families in the HEARTS Program, 14 in the Emergency Shelter, and 11 in TANF/Bridge side. We have 5 families placed at the Center for Hope and Safety (DV shelter). We had 55 Emergency Assistance applications and 93 clients on Temporary Rental Assistance. We had 33 placements as referrals from 211. We have 248 active DDD cases. The Adult Protective Service (APS) Unit received 81 referrals and currently have 45 open cases.

(b) Memoranda to the Board

Scott Modery reported that on July 28th Marilyn Gadomski, Social Worker, attended the "Age Friendly Bergen Roundtable" at the Garfield VFW. The gathering was attended by 40+ nonprofit and government entities who took the opportunity to exchange information. We have been notified that we are receiving an Area Agencies on Aging Adult Protective Services ARPA grant of \$319,683. Bergen has received the largest share of the total allocation of \$3,016,122. There are specific requirements on the usage of this funding, which dictate that it is to "enhance, improve, and expand the ability of APS" functions. It cannot be used for any other purpose and cannot supplant existing funding and therefore cannot be used to offset our general or APS budget. Rather, it will be used to enrich and increase the ability to deliver services. A preliminary CWA 1089 negotiation meeting is taking place on August 2, 2023 at 3:00 PM. It will be followed by the next negotiation meeting on August 24, 2023. We are hopeful that the contract will be settled before the current contract expiration of December 31, 2023. To date, we have heard no communication from CWA 1031 regarding their intentions to begin negotiations for their contract, which also expires on December 31, 2023. We have been instructed that until further notice, under the guidance of instructions promulgated in PHE unwinding releases, we are not permitted to impose recovery or recoupment from any beneficiary of Medicaid for incorrectly paid benefits. At current, this has only been communicated in an informal manner. We are awaiting further guidance from the Division of Medical Assistance and Health Services (DMAHS) who is coordinating with the Center for Medicare and Medicaid Services (CMS) to publish this official guidance. This will affect our revenue as we collect a portion of Medicaid recoveries. We are in the process of onboarding Montvale to our General Assistance (GA) administration roles. With the addition of Montvale, we will have 65 of 70 Bergen County municipalities to which we administer GA. A resolution will be presented at the September Board meeting. We are experiencing increasing difficulty in confirming meeting quorums each month. There is a growing amount of time being invested in calling individual Board Members to confirm their attendance. Scott Modery respectfully requested each Board Member to the best of their ability ensure that they respond to the Board Secretary's meeting notification either confirming or declining their attendance in order to simplify the process and guarantee that no members come to a meeting only to learn that a quorum is not met.
