#### **Presentation of 2022 Audit Report**

Matthew Wielkotz from Wielkotz & Company, LLC was present to discuss the 2022 annual Audit.

Mr. Wielkotz reported another year the Bergen County Board of Social Services audit had zero findings, which is very unusual, and is a testament to all the great work that Scott Modery, Geri Nestrowitz, and the Board are doing. This was the first year that Geri Nestrowitz was at the helm of the audit. He complimented the staff on providing information on time and in some cases early. Mr. Wielkotz thanked both Geri Nestrowitz and Scott Modery because his firm does some other work at other Boards of Social Services where there are some new fiscal people and they helped out some other counties with questions in the state.

Mr. Wielkotz left the meeting at approximately 4:40 p.m.

## **Administration Report:**

#### (a) Monthly Reports – Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery noted that again we have seen a spike in application activity for TANF and SNAP.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for August 2023 was 358 and July 2023 was 353 cases, and compared to one year ago it went up 52 cases, SNAP (Supplemental Nutrition Assistance Program) caseload for August 2023 was 23,194 and July was 22,958 and compared to one year ago it went up by 1,250 cases, GA (General Assistance) caseload for August was 420 and July was 407 cases and compared to one year ago it went up by 36 cases. In regard to Medicaid, there were 56,124 individuals in August and in July 2023 there were 57,939 individuals a decrease of 1,815 individuals.

Burial stats are as follows: 13 inquires, 22 approved, and 0 denials. The agency paid out \$107,383.00 and recovered \$473.08.

In August 2023, the agency received 1,967 applications for cash and SNAP applications and 1,728 Medicaid applications for a total of 3,695. In July 2023, the agency received 1,691 applications for cash and SNAP applications and 1,615 Medicaid applications for a total of 3,306.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 3 individuals/families in motels. We have 23 families in the HEARTS Program, 11 in the Emergency Shelter, and 12 in TANF/Bridge side. We have 9 families placed at the Center for Hope and Safety (DV shelter). We had 66 Emergency Assistance applications and 91 clients on Temporary Rental Assistance. We had 25 placements as referrals from 211. We have 247 active DDD cases. The Adult Protective Service (APS) Unit received 124 referrals and currently have 32 open cases.

#### (b) Memoranda to the Board

Scott Modery reported that we received three rounds of Supplemental Nutrition Assistance Program (SNAP) ARPA (American Rescue Plan Act) funding to assist with SNAP application and processing backlogs. The final day to utilize this funding was September 23, 2023. As these funds were subsidizing ongoing SNAP overtime processes, we can expect to see overtime costs increase dramatically. Additionally, Medicaid unwinding is also increasingly pressuring the need for overtime. Unfortunately, to date Medicaid has provided no administrative funding to address the massive increase in workload associated with the unwinding. These factors are likely to drive significantly elevated overtime costs for the foreseeable future. We continue to send a Social Worker from our Adult Protective Service (APS) Department to the "Age Friendly Roundtable" reoccurring event. This conference allows our APS Department to connect and coordinate with other area resources to promote and create age-friendly communities. We hosted a table at the "Annual Senior Festival" at Van Saun Park on September 12, 2023. We were represented by request by our APS Department at the "Elmwood Park Celebrates Seniors" event on September 30, 2023. We attended the "Bergen County Sheriff's Office reentry workshop". This event gives us the opportunity to learn how to work more closely with the Bergen County Jail to assist those individuals who are being reintegrated into the community. We sent four DDD staff to the Bergen County Department of Human Services "Self-Care is Not Enough: A Trauma-Informed Lens to Compassion Fatigue and Burnout Prevention for Professionals" webinar on September 28, 2023. The webinar was free for County employees; however, Mr. Modery was unfortunately unable to get our agency recognized under that County umbrella, which would have provided the training for free. Our final 2022 Audit report has been released, a copy of which was provided in the Board packet. We are proud to once again deliver an Audit report to the Board that contains no findings, questioned costs, or recommendations. Mr. Modery extended his greatest gratitude to the Finance Department and IT Department, as well as, the Agency Intake and Processing Departments for SNAP and Medicaid as these were also a subject to a portion of the audit. In all scenarios, the agency performed admirably. This would not be possible without the cooperation and coordination of the entire agency. Lastly, we have been making a drive toward minimizing our part-time staff. Mr. Modery shared a grid of where we are today, versus our historical position over the past three and one-half years. We are currently at our lowest percentage of part-time staff in years. Also noted, while there are part-time workers who are interested in full time many of our current part timers prefer to remain in a part time capacity.

## Chairman's Report

Chairman William E. Connelly mentioned that each month Scott Modery sends him a request for overtime, and he approves these requests based on need so staff do not fall behind and it does not affect or hurt our customers.
