- **WHEREAS**, the Director and Qualified Purchasing Agent have reviewed this matter and recommend the Board utilize Equitable as a third company to provide a deferred compensation plan to employees.
- **NOW, THEREFORE, BE IT RESOLVED**, by the Bergen County Board of Social Services that the addition of Equitable as a third company to offer a Deferred Compensation Plan to the Board employees be and is hereby approved; and

- **BE IT FURTHER RESOLVED**, that the Director of the Board be and is hereby designated as the Local Plan Administrator for the administration of the deferred compensation plan; and
- **BE IT FURTHER RESOLVED**, that the Director be and is hereby authorized and directed to execute the attached Service Agreement with Equitable on behalf of the Board; and

_____9. Matters Relating to the Potential Imposition of a Penalty. Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party bears responsibility.

NOW THEREFORE, BE IT RESOLVED, by the Bergen County Board of Social Services, assembled in public session on November 9, 2023 that an Executive Session closed to the public shall be held on December 5, 2023 at 4:30 P.M. at the Bergen County Board of Social Services, 218 Route 17 North, Rochelle Park, New Jersey, for the discussion of matters relating to the specific items designated above.

BE IT FURTHER RESOLVED, that it is anticipated that the deliberations conducted in closed session will be disclosed to the public upon the determination of the Bergen County Board of Social Services that the public interest will no longer be served by such confidentiality as set forth above.
