Administration Report:

(a) Monthly Reports - Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for September 2023 was 357 and August 2023 was 358 cases, and compared to one year ago it went up 32 cases, SNAP (Supplemental Nutrition Assistance Program) caseload for September 2023 was 23,918 and August was 23,194 and compared to one year ago it went up by 1,161 cases, GA (General Assistance) caseload for September was 442 and August was 420 cases and compared to one year ago it went up by 34 cases. In regard to Medicaid, there were 53,966 individuals in September and in August 2023 there were 56,124 individuals a decrease of 2,158 individuals.

Burial stats are as follows: 16 inquires, 18 approved, and 2 denials. The agency paid out \$51,987.00 and recovered \$2,774.00.

In September 2023, the agency received 1,754 applications for cash and SNAP applications and 1,642 Medicaid applications for a total of 3,396. In August 2023, the agency received 1,967 applications for cash and SNAP applications and 1,728 Medicaid applications for a total of 3,695.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 2 individuals/families in motels. We have 26 families in the HEARTS Program, 13 in the Emergency Shelter, and 13 in TANF/Bridge side. We have 9 families placed at the Center for Hope and Safety (DV shelter). We had 46 Emergency Assistance applications and 88 clients on Temporary Rental Assistance. We had 34 placements as referrals from 211. We have 244 active DDD cases. The Adult Protective Service (APS) Unit received 117 referrals and currently have 32 open cases.

(b) Memoranda to the Board

Scott Modery reported that Brendaly Sanchez and Annette Wilson hosted a table at the annual Fall Caregivers Conference on Saturday, October 14, 2023. The Board may have noticed that the SNAP Outreach schedule included with the Board packet has fewer Outreach sites than had been scheduled several months ago. The Community Food Bank of NJ has been running these outreach sites for several months and has determined that some only require less frequent visits while there has been a move to "digital referrals" on others. This is accomplished by a coordinator remotely

assisting residents rather than an in-person visit. The World of Resources event was attended by Maya Jacob and Gina Kennedy on October 3, 2023. Over the past few years during the pandemic, email usage increased dramatically. A large portion of this usage relates to new processes which allow clients to email certain case verifications. This increase has caused an unsustainable overhead on our email system. As a result, we have begun exploring cloud based email solutions. This is not an inexpensive solution; however, our current usage levels and continued expansion have caused increased down time and sporadic crashing. Upgrades are necessary before critical levels are reached. In conjunction with the County Department of Health Services, Ritzy Moralez-Diaz scheduled a "Flu Clinic" on site on November 2, 2023. Approximately 30 people were vaccinated on site. As previously noted, the immense overhead of post-pandemic work has necessitated a lot of overtime. All counties have experienced a drop in Medicaid timeliness as a result. Bergen is currently second in timeliness. While #2 is not usually something to "crow" about, it is important to note that the leading county is only .47% ahead of Bergen. Further, the leading county has only 11% of our caseload. Mr. Modery included a graph to illustrate further. On October 24, 2023 the agency hosted a Delegation of 24 representatives from South Korea. The group was interested in learning about our programs particularly as it related to SNAP, elder care services, and child services. Kija Hwang, Yvonne Jordan, Marlita Margono, Geraldine Nestrowitz, Ritzy Moralez-Diaz, Suzan Kirieakes, Allan Larobardier, Michael Sluka, Esq. and Scott Modery attended. In addition, Michele Darmochwal, Maryann Moyer, and Deborah Piccione have begun to plan for our 2023 Adopt-a-Family. We have decided that this year the primary focus will be the HEARTS shelter. Should we have sufficient sponsors we will expand to additional families. If anyone is interested in committing to adopting a family, please let us know as soon as possible but no later than November 30, 2023. If the Board agrees, we would like to take a full Board group photo at the January 2024 Board Meeting. Mr. Modery's plan is to frame and hang this photo. He suggested yearly January photos of the Board going forward to display in an around the Board Room to create a history of Bergen County Board of Social Services Board Members. Last month, Scott Modery reported that our Adult Protective Services (APS) Department was represented at the "Elmwood Park Celebrates Seniors" event in Elmwood Park. Lastly, in a moral booster event Ritzy Moralez-Diaz encouraged staff to dress

up for Halloween, and we had a very positive response.
