Administration Report:

(a) Monthly Reports - Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for October 2023 was 361 and September 2023 was 357 cases, and compared to one year ago it went up 22 cases. SNAP (Supplemental Nutrition Assistance Program) caseload for October 2023 was 23,423 and September 2023 was 22,918 and compared to one year ago it went up by 1,472 cases. GA (General Assistance) caseload for October 2023 was 467 and September 2023 was 442 cases and compared to one year ago it went up by 69 cases. In regard to Medicaid, there were 52,011 individuals in October 2023 and in September 2023 there were 53,966 individuals a decrease of 1,955 individuals.

Burial stats are as follows: 26 inquires, 34 approved, and 1 denial. The agency paid out \$61,910.00 and recovered \$4,651.56.

In October 2023, the agency received 1,980 applications for cash and SNAP applications and 1,829 Medicaid applications for a total of 3,809. In September 2023, the agency received 1,754 applications for cash and SNAP applications and 1,642 Medicaid applications for a total of 3,396.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 4 individuals/families in motels. We have 25 families in the HEARTS Program, 13 in the Emergency Shelter, and 12 in TANF/Bridge side. We have 9 families placed at the Center for Hope and Safety (DV shelter). We had 63 Emergency Assistance applications and 88 clients on Temporary Rental Assistance. We had 26 placements as referrals from 211. We have 243 active DDD cases. The Adult Protective Service (APS) Unit received 89 referrals and currently have 40 open cases.

(b) Memoranda to the Board

Scott Modery reported that we are planning to take a full Board photo at the January 9, 2024 meeting.

On November 27, 2023, Geraldine Nestrowitz and Scott Modery met with the County Treasurer, CFO, and several others to discuss our preliminary budget request. As the Board has been informed over the past months, Medicaid and SNAP have been overwhelming programs for Bergen and the entire state from application to case approvals, denials, and redeterminations. As such, we have requested an increase in funding to compensate for this crushing load. Mr. Modery included some graphs, which were distributed. He offered to discuss in more detail upon request. We are exploring the possibility of distributing "years of service" pins to employees. These pins are distributed in 5year increments starting at 10 years of service and was done until several years ago when it was discontinued. We currently have 110 employees who would be eligible. Our longest serving employee Marilyn Gadomski will have 40 years of service in April 2024. In Mr. Modery's August Board memorandum, he reported that we were receiving \$319,683 in American Rescue Plan (ARP) funding to "enhance, improve, and expand the ability of APS functions". He reported that this money cannot supplant existing funding. As such, we have added some staff to our Adult Protective Service (APS) Department and purchased a 2023 Chevrolet Traverse to be used exclusively by our APS Department. The Division of the Deaf and Hard of Hearing (DDHH) will conduct five Deaf Sensitivity Training sessions for a portion of our staff during the month of December. We have adopted all interested families in the HEARTS shelter, 23 families in total. Additionally, 4 families outside of HEARTS have also been adopted. More families have been added to a waiting list. The deadline is December 15, 2023 for adopter gift delivery.
