Administration Report:

(a) Monthly Reports - Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for March 2024 was 355 and February 2024 was 357 and compared to one year ago it went down 27 cases. SNAP (Supplemental Nutrition Assistance Program) caseload for March 2024 was 23,868 and February 2024 was 23,497 and compared to one year ago it went up by 1,110 cases. GA (General Assistance) caseload for March 2024 was 528 and February 2024 was 514 and compared to one year ago it went up by 103 cases. In regard to Medicaid, there were 46,788 individuals in March 2024 and in February 2024 there were 47,516 individuals a decrease of 728 individuals.

Burial stats are as follows: 23 inquires, 26 approved, and 2 denials. The agency paid out \$103,430.00 and recovered \$0.00.

In March 2024, the agency received 1,618 applications for cash and SNAP applications and 2,048 Medicaid applications for a total of 3,666. In February 2024, the agency received 1,644 applications for cash and SNAP applications and 2,064 Medicaid applications for a total of 3,708.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 4 individuals/families in motels. We have 19 families in the HEARTS Program, 10 in the Emergency Shelter, and 9 in TANF/Bridge side. We have 12 families placed at the Center for Hope and Safety (DV shelter). We had 49 Emergency Assistance applications and 86 clients on Temporary Rental Assistance. We had 29 placements as referrals from 211. We have 240 active DDD cases. The Adult Protective Service (APS) Unit received 94 referrals and currently have 34 open cases.

(b) Memoranda to the Board

Scott Modery reported that Michael Biggar and Sarah Fuhrman, as representatives of Adult Protective Services, SNAP, and ABD Medicaid attended the Annual Spring Caregivers Conference on Thursday, April 11, 2024. Subsequently, we received a thank you from Bergen County Department of Human Services (DHS) Division of Senior Services. On Friday April 12, 2024, CWA 1089 sponsored a jeans day and raised \$670 to support "Bring your Child to Work Day" held on April 25th. There is a resolution on this evening's agenda for the transfer of Rutherford

General Assistance to the Bergen County Board of Social Services (BCBSS). This transfer will complete all 70 municipalities in Bergen County to the BCBSS. On Tuesday, April 30, 2024 Sonia Aufiero and Scott Modery attended the "Public Hearing on the Needs of Older Adults in Bergen County". NJ Department of Family Development has expanded features of the online portal "MYNJHelps" (https://mynjhelps.gov). This State managed portal allows residents to apply for SNAP, TANF, and General Assistance online. This expansion of capabilities allows new and existing applicants additional abilities such as seeing case status, benefit amount, certification dates, certification period, members in their household, and notices. While not completely seamless in its application process, this portal also provides connections to the NJ Family Care application portal. On Thursday, April 25, 2024 Ritzy Moralez-Diaz organized "Bring your Child to Work" day. We had a very large turnout of 73 children ranging from 5 to 17 years old. Different activities were organized for different age groups, but all children got to spend some time with their parent at their workstation. The day ended with pizza for everyone. Sheri Watson, Geraldine Nestrowitz, and Scott Modery met with our Qualifying Purchasing Agent, Gerald Reiner, on April 30, 2024. Mr. Reiner requested a quick meeting to touch base and talk about any upcoming purchases that he should be aware of. They discussed some plans for the upcoming year and beyond. There were some questions asked at the Board Meeting held on April 2nd regarding SNAP denials. We have begun a formal monthly reporting of denial reasons beginning with May 2024. A chart was distributed with the Board packet that showed combined March and April denial reasons. Overwhelmingly cases are denied due to required information not being provided. We continue to research statistics on reapplication counts.
