Administration Report:

(a) Monthly Reports – Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for April 2024 was 332 and March 2024 was 355 and compared to one year ago it went down 48 cases. SNAP (Supplemental Nutrition Assistance Program) caseload for April 2024 was 24,000 and March 2024 was 23,868 and compared to one year ago it went up by 1,581 cases. GA (General Assistance) caseload for April 2024 was 552 and March 2024 was 528 and compared to one year ago it went up by 125 cases. In regard to Medicaid, there were 45,788 individuals in April 2024 and in March 2024 there were 46,788 individuals a decrease of 1,000 individuals.

Burial stats are as follows: 36 inquires, 22 approved, and 1 denial. The agency paid out \$95,044.00 and recovered \$3,362.50.

In April 2024, the agency received 1,695 applications for cash and SNAP applications and 2,009 Medicaid applications for a total of 3,704. In March 2024, the agency received 1,618 applications for cash and SNAP applications and 2,048 Medicaid applications for a total of 3,666.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 8 individuals/families in motels. We have 22 families in the HEARTS Program, 9 in the Emergency Shelter, and 13 in TANF/Bridge side. We have 9 families placed at the Center for Hope and Safety (DV shelter). We had 46 Emergency Assistance applications and 87 clients on Temporary Rental Assistance. We had 39 placements as referrals from 211. We have 240 active DDD cases. The Adult Protective Service (APS) Unit received 94 referrals and currently have 27 open cases.

(b) Memoranda to the Board

Scott Modery reported that to welcome Summer, our two Administrators and Assistant Administrator (Yvonne Jordan, Allan Larobardier, & Marlita Margono) delivered ice cream to all agency staff at the end of the day on the Friday before Memorial Day. We are increasing the SNAP E&T (Employment and Training) payment issued to clients to \$78. Some of these payments will appear on the vouchers list but most are issued through State systems. Historically, we have issued \$76 per month based upon the cost of a two-zone bus pass, which gives clients access to most of

Bergen County. A two-zone bus pass is now \$78. This increase has no impact on County funding and after a conversation with the Board attorney we have agreed that no resolution is necessary for this change. Our negotiations have culminated in a signed Memorandum of Agreement with CWA 1031. Negotiations are ongoing with CWA 1089. We await a signed contract, which will likely be presented for resolution and signature at the July meeting. The 2023 Fiscal agency audit officially began the week of May 13th. Based upon past history the entire audit should take approximately four to six weeks. On May 23rd and May 24th, the Department of Family Development (DFD) provided Customer Service Training in four sessions at our facility. Over one hundred BCBSS employees attended the training.
