Administration Report:

(a) Monthly Reports – Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for May 2024 was 314 and April 2024 was 332 and compared to one year ago it went down 71 cases. SNAP (Supplemental Nutrition Assistance Program) caseload for May 2024 was 23,810 and April 2024 was 24,000 and compared to one year ago it went up by 1,052 cases. GA (General Assistance) caseload for May 2024 was 542 and April 2024 was 552 and compared to one year ago it went up by 121 cases. In regard to Medicaid, there were 44,259 individuals in May and 45,788 individuals in April 2024 a decrease of 1,529 individuals.

Burial stats are as follows: 35 inquires, 29 approved, and 0 denials. The agency paid out \$78,103 and recovered \$862.44.

In May 2024, the agency received 1,668 applications for cash and SNAP applications and 1,916 Medicaid applications for a total of 3,584. In April 2024, the agency received 1,695 applications for cash and SNAP applications and 2,009 Medicaid applications for a total of 3,704.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 5 individuals/families in motels. We have 23 families in the HEARTS Program, 11 in the Emergency Shelter, and 12 in TANF/Bridge side. We have 9 families placed at the Center for Hope and Safety (DV shelter). We had 51 Emergency Assistance applications and 88 clients on Temporary Rental Assistance. We had 22 placements as referrals from 211. We have 240 active DDD cases. The Adult Protective Service (APS) Unit received 106 referrals and currently have 30 open cases.

(b) Memoranda to the Board

Scott Modery reported that on June 25th Lorraine Slovak and Annette Wilson attended the annual Food Pantry Summit at Bergen Community College. The State, under mandate by the Food and Nutrition Service (FNS), is preparing to release a "SNAP Dashboard". This dashboard will show statewide statistics as they relate to timeliness, approval rates, and denial reasons. Release was scheduled for June but has been pushed back to August. Snapshots of what the dashboard will look like were distributed with the memorandum to the Board Members. We are entering our first period

since Medicaid unwinding when cases with grace periods and extensions to provide data will expire. This means that there will be a significant number of cases which will more than likely close in the next few months. NJAC is voicing support and is encouraging counties to adopt resolutions supporting online legal notices. We look forward to being able to electronically publish information. The practice of requiring publishing in printed newspaper publications is in need of updating. Yvonne Jordan and Marlita Margono visited the Community Food Bank Food Pantry at the Greater Bergen Community Action Unity Health Center on Monday, July 1st. They were very impressed with the facility. We will be publicizing the facility with some postings in our lobbies, and we are evaluating a posting location for our website. A link to explore more information about the facility was distributed with the memorandum to the Board Members. At our June 4th Board meeting there was a request for some additional statistics across various programs. The most recent monthly data analysis provided by the Department of Family Development was distributed with the memorandum to the Board Members.
