## **Administration Report:**

#### (a) Monthly Reports – Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for August 2024 was 302 and July 2024 was 295 and compared to one year ago it went down 56 cases. SNAP (Supplemental Nutrition Assistance Program) caseload for August 2024 was 24,210 and July 2024 was 24,262 and compared to one year ago it went up by 1,016 cases. GA (General Assistance) caseload for August 2024 was 553 and July 2024 was 560 and compared to one year ago it went up by 133 cases. In regard to Medicaid, there were 42,095 individuals in August and 42,301 individuals in July 2024 a decrease of 206 individuals.

Burial stats are as follows: 27 inquires, 23 approved, and 1 denial. The agency paid out \$104,415.00 and recovered \$1,760.66.

In August 2024, the agency received 1,917 applications for cash and SNAP applications and 2,167 Medicaid applications for a total of 4,084. In July 2024, the agency received 1,881 applications for cash and SNAP applications and 2,410 Medicaid applications for a total of 4,291.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 9 individuals/families in motels. We have 23 families in the HEARTS Program, 11 in the Emergency Shelter, and 12 in TANF/Bridge side. We have 7 families placed at the Center for Hope and Safety (DV shelter). We had 70 Emergency Assistance applications and 92 clients on Temporary Rental Assistance. We had 31 placements as referrals from 211. We have 237 active DDD cases. The Adult Protective Service (APS) Unit received 125 referrals and currently have 33 open cases.

#### (b) Memoranda to the Board

Scott Modery reported that on September 6, 2024, CWA 1089 sponsored an Alzheimers Jeans Day and raised over \$650 for the Alzheimers foundation. Additionally, on September 20, 2024, CWA 1089 sponsored a second Jeans Day, which raised \$540 which will be used to purchase Shoprite and/or Target gift cards to provide to our Adult Protective Service or any other immediate need client. Mr. Modery thanked the staff for donating \$1,190 in one month to these causes. On

September 11, 2024, we were notified of an award of \$93,899 from the State of NJ to assist in SNAP related overtime costs retroactive to July 1, 2024. This money must be spent by June 30, 2025. We have been tracking our SNAP overtime costs in hopes of receiving this money and as of September 30th we spent over 40% of this grant money. On September 12, 2024, Dolores Phillips and Mike Biggar hosted a table at the Senior Festival at Van Saun County Park in Paramus. Our Adult Protective Services Supervisor, Sonia Aufiero, attended the National Adult Protective Services Association (Home - NAPSA (napsa-now.org)) conference in Albuquerque, New Mexico from September 16 to September 18, 2024. The NAPSA conference is an inclusive gathering of Adult Protective Services (APS) professionals from across the United States. This event brings together professionals from diverse backgrounds to share insights, learn together, and build connections. Ms. Aufiero was also able to exchange ideas with the statewide APS coordinator and after learning of Bergen's processes and positive relationships with law enforcement and municipalites, other Counties have expressed interest in visiting Bergen County to learn tactics to improve their APS tactics. On September 16, 2024, we were notified that our Qualified Purchasing Agent was no longer with the Bergen County Utilities Authority (BCUA). The BCUA indicated that as such they were unable to continue with the existing shared services agreement. County Executive Tedesco has offered to assist BCBSS via a new shared services agreement with the County Division of Purchasing. On September 24, 2024, Mr. Modery and staff met with the County QPA Peter Garrity.

On September 4, 2024, Allan Larobardier, Yvonne Jordan, Marlita Margono, and Scott Modery met with Patrick Fallon, Project Coordinator, for the Bergen County Office of Food Security for a demo and discussion regarding their online referral system "OASIS". They discussed potential roles that BCBSS could play regarding this resource. The SNAP Dashboard mentioned in prior Board Memos has been launched here: https://www.nj.gov/humanservices/dfd/news/dashboard/. Data has been deployed County by County and Statewide on metrics including timeliness, approval and denial rates, and denial reasons. When observing data, it is important to note the State's disclaimer: "The approval rate is not reflective of county processes but can be attributed to a variety of causes including county demographics and program eligibility". Some data is questionable, and Mr. Modery has an open conversation with State personnel. Two graphs taken from the SNAP Dashboard site were distributed with the Board packet. Mr. Modery explained that blue areas represent denials in which documentation was not provided. This large percentage of denials is a consistently large factor for denial across all 21 counties. In regard to the state's statistics, we found a problem with their statistics. Bergen County has an incorrect low approval rate. Mr. Modery has been in touch with the State regarding this and they acknowledged that this is an issue for several counties. Our cases approved is a higher number than what is being represented there.

On September 20, 2024, Allan Larobardier along with two client reception and interviewing supervisors and two Emergency Assistance staff met with Kristen Rendini, Director, of the NJRC

(NJ Reentry Corporation) in Hackensack. We have been working with the NJRC for years and continue to maintain a positive relationship to assist our clients who are eligible for their services.

On September 30, 2024, we received notice that SNAP benefits stolen through card skimming, cloning, or other methods will be eligible for replacement until December 31, 2024. See the FNS website information here: Addressing Stolen SNAP Benefits | Food and Nutrition Service (usda.gov). Additionally, we have identified a new scam which involves false text messages to clients asking them to confirm SNAP eligibility. DFD was notified and they are aware.

We have enrolled in the United Council on Welfare Fraud (<a href="https://www.ucowf.net/">https://www.ucowf.net/</a>). The United Council on Welfare Fraud is the only national membership association dedicated to defending against the erosion of integrity in public assistance programs — equipping members across the industry with crucial resources for collaboration, professional development, and advocacy. They provide resources to members identify, investigate, prosecute, and recover fraud in these programs. They also publish monthly newsletters containing important information including potential pending legislation.

Mr. Modery reported that January is picture month. A full Board group photo will be taken at the January 2025 Board Meeting to display in and around the Board Room to create a history of Bergen County Board of Social Services Board Members.
