Administration Report:

(a) Monthly Reports - Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for October 2024 was 295 and September 2024 was 307 and compared to one year ago it went down 66 cases. SNAP (Supplemental Nutrition Assistance Program) caseload for October 2024 was 24,886 and September 2024 was 24,384 and compared to one year ago it went up by 1,463 cases. The GA (General Assistance) caseload for October 2024 was 551 and September 2024 was 552 and compared to one year ago it went up by 84 cases. In regard to Medicaid, there were 43,022 individuals in October and 42,472 individuals in September 2024 an increase of 550 individuals.

Burial stats are as follows: 45 inquires, 28 approved, and 0 denials. The agency paid out \$101,141.00 and recovered \$3,293.08.

In September 2024, the agency received 1,822 applications for cash and SNAP applications and 2,182 Medicaid applications for a total of 4,056. In September 2024, the agency received 1,822 applications for cash and SNAP applications and 2,096 Medicaid applications for a total of 3,918.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 8 individuals/families in motels. We have 22 families in the HEARTS Program, 12 in the Emergency Shelter, and 10 in TANF/Bridge side. We have 10 families placed at the Center for Hope and Safety (DV shelter). We had 59 Emergency Assistance applications and 95 clients on Temporary Rental Assistance. We had 15 placements as referrals from 211. We have 234 active DDD cases. The Adult Protective Service (APS) Unit received 124 referrals and currently has 36 open cases.

(b) Memoranda to the Board

Scott Modery reported that as mentioned in his November Board memo, we are planning to take a full Board photo at the January 14, 2025 Board Meeting. Adopt-a-Family is in full swing. To date, we have 17 families from the HEARTS shelter adopted. We have successfully connected once again with the Closter PBA toy drive for December 19th. We plan on matching these gifts to our past HEARTS residents with children of appropriate age. After most of the year and countless hours of preparation, our IT team will be moving our email services off of our on premise server and into the Microsoft 365 cloud. This months long project required so much time to ensure security and to preserve all existing emails. If all goes according to plan, the end user will notice little difference in their interface other than improved speed. November was our worst month on record for stolen/skimmed benefits at approximately 635 reported cases. It is important to note that our ability to replace stolen benefits expires on December 20, 2024. Additionally, the volume of replacements necessary is quickly beginning to outpace our staff time to replace them. This quantity of replacements requires about 318 man-hours (over 45 days of work) to replace the benefits. This removes staff from other crucial time sensitive duties and is quickly becoming unsustainable. In a moral booster event – staff were permitted to dress up for Halloween on October 30th. At afternoon break a contest was held to choose two winners. Ritzy Moralez-Diaz from our Personnel Department and Sarah Furman from our Division of Developmental Disabilities Department attended a free "Mental Health First Aid" class on November 14th. This course was offered by the County and teaches how to identify, understand, and respond to signs of mental health and substance abuse challenges. On November 25th, Geraldine Nestrowitz and Mr. Modery met with the County CFO to discuss our preliminary 2025 budget request. As mentioned in a previous Board memo, our health benefit increases have driven our budget request up significantly. This factor alone is primarily responsible for most of our increase. It also is something which we are unable to control.
