Christine Murphy - President of CWA 1089

Ms. Murphy thanked all those Board Members that attended the Employee Breakfast and took their time to take a tour and look at the working conditions on Floor 5. She mentioned that she hopes a conversation will be held in private regarding exactly what that looks like. She indicated that it has been over a month, and they have ceiling divertors in their workspaces. She asked for a member to be moved over one week ago, and the employee is still sitting at their desk with water coming in where the employee sits. She indicated that these are not acceptable working conditions. She relayed that she really wants the Board to address this in whichever way it can be. She indicated that nobody should ever be forced to work in a condition where literally the outside is coming inside. She discussed that any employee who has water coming in by them should be able to be moved upon saying they don't want to be wet or have an umbrella in their office.

She indicated that last month, the Board thanked the supervisor of the AA Unit. They have been able to catch up on a lot of their Medicaid, and she thinks that is fantastic. She expressed that the supervisor of the AA Unit is a great supervisor. However, she also expressed that it is not only about the supervisor or the management team. It is about the individuals. She mentioned that although some of those individuals were present at this afternoon's Board Meeting, she wanted to name all of them. She indicated without the members that are here today or without the individuals that work here none of that would get done. At this point in time, she read aloud approximately 14 names. At last month's Board Meeting, she indicated that nobody from the public wanted to speak during the Open Public Comment Period because the Board is intimidating. She thought some Board Members looked a little shocked about hearing that. She indicated that she has been employed by the agency for 13 years and the Board really has not heard from her. As President of CWA 1089, she now represents every member in CWA 1089 and, therefore, she will come and shed a light on all of the issues that are currently happening in the agency and there are a lot. Most of the people here do not feel comfortable coming and speaking up because when they do they feel there is a target on their back. She mentioned why does the Board think that someone like herself who is so vocal at this point in time has not spoken for the last 13 years. Communication has broken down a little bit over the last couple of weeks. She hopes that it comes back. She indicated that we have issues right now in our parking lot, building, and with just following contract. Some of the things they are asking for are just following the contract as written and some of it is also just human. She indicated just because something is law does not mean that it is the only way you can do it. The FMLA Policy that we have is hurting employees, particularly young mothers. Ms. Murphy asked for things such as statistics to be able to address staffing concerns. Last month, she asked the Board to look at the Budget and at that time when you look to do the Budget the question, she missed in asking was how many people we are looking to fill positions. She understood that we are currently at 248, and we are asking for 251. In her humble opinion, that is not going to take care of the backlog that is in certain departments including the DIMS Department and her own department, the BL Unit. She indicated that there needs to be people in seats to help the people in Bergen County. Without all the people behind her, they cannot do that. She asked the Board to listen to her words and to truly just hear what they have to say. She is hoping that next month she is coming back cheerful and positive. Her plan is every month to come and bring a different unit with her to be able to show the Board who these people are and what they do. Last month, the AA Unit was talked about. She thinks that every one of our employees deserves to be mentioned. She indicated that the Board should know the names of every single staff member. Because without them, this agency does not run.

Chairman William E. Connelly commented that he has sat on this Board for 15-plus years and knows everyone who sits on the Board. He clarified that there is not a target on anybody's back! As Chairman of this Board, and for everyone that represents this Board, that comment is not so. He indicated his door is always open and everyone knows how to reach him. He can be reached through the administrative office or anytime before or after a Board Meeting. The Board has concerns and they address those concerns. He thanked Ms. Murphy for sharing her feelings but expressed that he had to share his too. Junior Hernandez, Ph.D., disagreed with Ms. Murphy and agreed with the Chairman.

Elaine K. Meyerson thanked those members who came to this afternoon's Board Meeting for the Board to meet them. She mentioned that the Board definitely appreciates all the work that they do!

Junior Hernandez, Ph.D., mentioned that although he does not agree with Ms. Murphy it is good to know how she and her members feel.

Administration Report:

(a) Monthly Reports - Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for January 2025 was 278 and December 2024 was 273 and compared to one year ago it went down 69 cases. SNAP (Supplemental Nutrition Assistance Program) caseload for January 2025 was 24,890 and December 2024 was 25,090 and compared to one year ago it went up by 1,419 cases. The GA (General Assistance) caseload for January 2025 was 548 cases and December 2024 was 544 and compared to one year ago it went up by 41 cases. In regard to Medicaid, there were 42,986 individuals in January 2025 and 43,325 individuals in December 2024 and compared to one year ago there is a decrease of 6,852 individuals. In regard to Medicaid individuals, in contrast to where we

peaked coming out of the Public Health Emergency (PHE) our peak was in May 2023 at 61,000 individuals. There has been an approximate 20,000 drop and that is expected because the PHE kept everyone on and cases could not be closed during that time. The peak for SNAP was November 2021 and that was 23,700 so SNAP is actually gone up even from what was the peak during the PHE, which is positive in so far as Bergen County residents that are receiving additional benefits from the program. Not such a great thing because more people are eligible.

Burial stats are as follows: 43 inquires, 38 approved, and 0 denials. The agency paid out \$106,181.71 and recovered \$5,435.18.

In January 2025, the agency received 2,031 applications for cash and SNAP applications and 2,281 Medicaid applications for a total of 4,312. This is the second highest rate of cash and SNAP applications we have seen behind January 2023 which was 2,092. In December 2024, the agency received 1,388 applications for cash and SNAP applications and 2,356 Medicaid applications for a total of 3,744.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 4 individuals/families in motels. We have 22 families in the HEARTS Program, 12 in the Emergency Shelter, and 10 in TANF/Bridge side. We have 6 families placed at the Center for Hope and Safety (DV shelter). We had 45 Emergency Assistance applications and 89 clients on Temporary Rental Assistance. We had 20 placements as referrals from 211. We have 232 active DDD cases. The Adult Protective Service (APS) Unit received 143 referrals and currently has 30 open cases.

(b) Memoranda to the Board

Scott Modery reported that on February 5th the agency was contacted by an attorney who was preparing a client's will. The attorney indicated that their client wanted to leave money in their will to BCBSS for the benefit of the SNAP program. The attorney stated "...a senior client who would like to donate some money to BCBSSS in her will...". This is clearly a person who not only received great benefit from SNAP but feels strongly enough about her positive experience at BCBSS to place the agency in her will. In a morale building event, Ritzy Moralez-Diaz arranged a football jersey day on February 7th. On February 18th Allan Larobardier, Sonia Aufiero, and Scott Modery along with Jared Lautz, Commissioner Zur, Melissa Debartolo, and others attended a HEARTS shelter tour for John Donnadio, Executive Director, of the New Jersey Association of Counties. Mr. Donnadio was impressed by not only the shelter itself, but the support programs and collaboration between County partner agencies to provide services for both current residents and for those seeking to enter the shelter. The HEARTS shelter is held up as a model for other counties in the state who have little or no comparable resources. The agency held an "Employee Breakfast" on Wednesday, February 19th. The gathering was well attended by staff, as well as, Commissioner Sullivan, and Board Members Susan Silverstein and Junior Hernandez, Ph.D. Years of service pins were awarded to 21 employees for achievements ranging from 10 years to 35 years of service. After breakfast, Mr. Modery received a communication from the County Executive's office congratulating our staff and requesting to be notified about these events in the future to allow the County Executive and all County Commissioners the opportunity to attend. On February 27th, CWA 1089 sponsored a Jeans Day fundraiser for the American Heart Association in support of American Heart Month. Gina Kennedy, Louise Gormley, and Alicia Steed are attending a two day "Poverty Immersion Training" on March 3rd and 4th. This program has been arranged by Tammy Molinelli, Executive Director, of the Bergen County Workforce Development Board. This multi-agency training opportunity is designed to help staff who work with people in poverty see the world from their perspective. In response to the recent leaks on the 5th floor and employee concerns, Mr. Modery arranged for environmental testing for "fungal spores & particulates" which was performed on February 21st. The final report will be issued shortly; however, the vendor summarized the preliminary result as follows: "In summary, the results indicate very low to low levels of airborne mold spores throughout the 5th floor. In fact, no airborne mold spores were detected at several of the 5th floor testing locations. Overall, the results indicate that there is not an unusual airborne mold condition on the 5th Floor, and consequently, there is no need for any mold-specific remedial response actions, in our professional opinion".

A recent National Adult Protective Services Association (NAPSA) forum communication raised the possibility of Social Services Block Grant (SSBG) and Adult Protective Services (APS) money being in jeopardy. BCBSS currently receives \$1,553,889 in APS and SSBG Funding. A loss of which would be devastating and unsustainable. Mr. Modery shared important resources that included a PowerPoint presentation and SSBG form with the Board. At a Department of Developmental Disabilities (DDD) webinar on February 27th, there was talk about Federal proposals to cut the Federal match on this program. BCBSS projects over \$1 million in 2025 to fund employee salaries associated with DDD. The NJ DHS newsletter released on February 27th contains an analysis of potential impacts of congressional budget proposals to N.J. Medicaid provider payments, eligibility, benefits, and what would invariably impact County Social Service Agencies across New Jersey. An important note on how these changes would impact BCBSS. BCBSS's total expenses are over 90% salary related. We maintain a low cash balance and no reserve. Should any of these cuts occur, there is the potential for an unrecoverable situation where we would not have cash on hand to function.

No fraud referrals sent to the Prosecutor's office during the month of February.
