# Administration Report:

## (a) Monthly Reports - Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for March 2025 was 275 and February 2025 was 281 and compared to one year ago it went down 80 cases. SNAP (Supplemental Nutrition Assistance Program) caseload for March 2025 was 25,008 and February 2025 was 24,884 and compared to one year ago it went up by 1,140 cases. The GA (General Assistance) caseload for March 2025 was 557 and February 2025 was 559 cases and compared to one year ago it went up by 29 cases. In regard to Medicaid, there were 42,972 individuals in March 2025 and 42,716 individuals in February 2025 and compared to one year ago there is a decrease of 3,816 individuals.

Burial stats are as follows: 30 inquiries, 34 approved, and 1 denial. The agency paid out \$77,397.00 and recovered \$684.62.

In March 2025, the agency received 1,491 applications for cash and SNAP applications and 1,884 Medicaid applications for a total of 3,375. In February 2025, the agency received 1,344 applications for cash and SNAP applications and 1,615 Medicaid applications for a total of 2,959.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 8 individuals/families in motels. We have 23 families in the HEARTS Program, 13 in the Emergency Shelter, and 10 in TANF/Bridge side. We have 4 families placed at the Center for Hope and Safety (DV shelter). We had 70 Emergency Assistance applications and 101 clients on Temporary Rental Assistance. We had 37 placements as referrals from 211. We have 230 active DDD cases. The Adult Protective Service (APS) Unit received 89 referrals and currently has 35 open cases.

#### (b) Memoranda to the Board

Scott Modery reported that on April 2, 2025 our Adult Protective Services (APS)

Supervisor attended a free event held at the Division of Senior Services at Bergen New Bridge Medical Center. As part of the "Dementia Friendly Initiative" the goal is to educate and inform health care professionals about the challenges people face when diagnosed with dementia. The event featured two retired physicians who are living well with dementia as educators and advocates.

On April 10, 2025 Sarah Furman and Ann Ryan attended the "Caregivers Conference" at One Bergen County Plaza. The conference is a learning experience about services and support for those who provide care for a loved one or neighbor. An interesting study released by the Food and Nutrition Service (FNS) related to SNAP benefits found that an estimated 88% of eligible people nationwide received SNAP benefits in FY 2022. For the same period, New Jersey performed above the average at 91%. Additionally for comparison, in FY 2020 the percentage of all eligible persons nationwide was 81%, and in January 1994 the nationwide percentage was 71%. In spite of the need for Geraldine Nestrowitz and Scott Modery to deliver less than optimal news, our Budget Hearing at the County on April 7th went well. They noted, among other things, that health benefits, pension, and building lease costs were major drivers of our 4.88% requested increase. Additionally, on April 24<sup>th</sup> we received a budget approval from the New Jersey Department of Community Affairs, Division of Local Government Services, that the Division of Family Development and the Medicaid portions of our 2025 budget were approved. On April 24th, Mr. Modery attended the first meeting of the newly formed Office of Food Security Advisory Board. As per the newly formed Board's bylaws, "The purpose of the Food Security Advisory Committee is to support and further the mission of the Bergen County Office of Food Security, and address important issues facing food insecure residents of Bergen County and the organizations in the community that support them". While many members of the Board are serving the community in the capacity of food banks and their support systems, Mr. Modery hoped that his presence could provide some support or insight for community members who visit this agency for SNAP or other services.

On April 24<sup>th</sup> we received our final Workfirst New Jersey Management Evaluation report from the NJ Department of Human Services Division of Family Development Office of Program Compliance. The "Findings" section noted "The reviewers found no errors in eligibility determinations, no payment errors, and no documentation errors. This was a positive review". The Executive Summary also noted in part "The results of the review show that Bergen County CSSA does an excellent job in administering the programs within the program rules. During the tour DFD staff was impressed by the county's organization, their processes for processing and monitoring the processing cases, and their ability to adapt to changes and challenges all while keeping timeliness deadlines". The review was in all ways very positive and speaks to the diligence of BCBSS staff. The entire Management Evaluation review can be found at: Bergen WFNJ-ME FFY25 Management Evaluation Report.pdf. On Aril 30<sup>th</sup> numerous agency employees did a "clap out" on the final day of

Katica Mustac. Ms. Mustac was hired in 1986 and is leaving with 39 years of service to BCBSS. The video is posted here: Katica Mustac Clap out.

In regard to the BCBSS budget, there continues to be persistent uncertainty about BCBSS funding moving forward. At Mr. Modery's May 2<sup>nd</sup> meeting with DFD and DMAHS both entities reported difficulties in obtaining any meaningful information from the Reconciliation Bill in Congress. Some items on the table currently are:

- <u>Medicaid:</u> Major cuts for Federal matching dollars, tightening of eligibility, addition of work requirements, and more frequent redeterminations.
- SNAP: Cost sharing (State/County) for administrative funding dollars, cost sharing (State/County) for benefits, and eliminating broad based categorical eligibility.
