Administration Report:

(a) Monthly Reports - Statistical & Financial:

A snapshot of caseload and expenditures was included in each of the Board Member's packets.

Scott Modery reported that the TANF (Temporary Assistance to Needy Families) caseload for April 2025 was 267 and March 2025 was 275 and compared to one year ago it went down 65 cases. SNAP (Supplemental Nutrition Assistance Program) caseload for April 2025 was 25,344 and March 2025 was 25,008 and compared to one year ago it went up by 1,344 cases. The GA (General Assistance) caseload for April 2025 was 581 and March 2025 was 557 cases and compared to one year ago it went up by 29 cases. In regard to Medicaid, there were 42,882 individuals in April 2025 and 42,972 individuals in March 2025 and compared to one year ago there is a decrease of 2,906 individuals.

Burial stats are as follows: 25 inquiries, 28 approved, and 0 denials. The agency paid out \$150,439.55 and recovered \$461.85.

In April 2025, the agency received 1,432 applications for cash and SNAP applications and 1,721 Medicaid applications for a total of 3,153. In March 2025, the agency received 1,491 applications for cash and SNAP applications and 1,884 Medicaid applications for a total of 3,375.

Our Emergency Assistance Unit assisted homeless individuals and families. Currently, we have 8 individuals/families in motels. We have 23 families in the HEARTS Program, 13 in the Emergency Shelter, and 10 in TANF/Bridge side. We have 6 families placed at the Center for Hope and Safety (DV shelter). We had 62 Emergency Assistance applications and 101 clients on Temporary Rental Assistance. We had 27 placements as referrals from 211. We have 227 active DDD cases. The Adult Protective Service (APS) Unit received 133 referrals and currently has 36 open cases.

(b) Memoranda to the Board

Scott Modery reported that on May 6, 2025 Allan LaRobardier attended the "Public Hearing on the Needs of Older Adults" at One Bergen County Plaza. The hearing serves as the

primary forum to gather information about the needs and concerns of seniors in Bergen County. On May 4, 2025, Linnybeth Canizales and Emily Sandnes staffed a table at the "Bergen County Care Fair" at Fairleigh Dickinson University's Bogota Savings Center Bank in Hackensack. The Care Fair's mission is to bring health care providers, support services, and field professionals together in one place to help residents make the necessary connections they need. On May 22, 2025, Ritzy Moralez-Diaz, Deborah Piccone, Geraldine Nestrowitz and Scott Modery met with three representatives from the NJCSC (New Jersey Civil Service Commission). NJCSC schedules regular meetings with entities across the state to answer questions, provide advice, and seek feedback as to how they can improve processes. On May 30, 2025, Kristen Nagy and Maya Jacob attended the Bergen County Food Pantry Summit at the Moses Center at Bergen Community College. The Summit is a conference where food pantry directors, emergency food providers, and direct service providers collaborate and share information. Also on May 30 2025, CWA 1089 sponsored a Jeans Day in benefit of the "Jed Foundation" which is a nonprofit that protects emotional health and prevents suicide for our nations young adults giving them skills and support they need to thrive: Jedfoundation.org. On May 14, 2025, the BCBSS Budget was approved by the Bergen County Commissioners. We received official notification on April 24, 2025 that the New Jersey Department of Community Affairs, Division of Local Government Services, Division of Family Development as well as the Division of Medical Assistance and Health Services approved our budget. Our 2025 budget approvals are now complete. The 2025 Board plaque has arrived and is hanging in the Board room.

In regard to the BCBSS budget update, DFD (Department of Family Development) and DMAHS (Division of Medical Assistance and Health Services) continue to express persistent uncertainty about program changes and funding moving forward. Several items which relate to SNAP and Medicaid appear poised to advance.

SNAP - the final reconciliation bill will likely shift a portion of SNAP administrative costs to Bergen County. Initial estimates compiled by DFD forecast an additional \$2,790,000 which would be added to the BCBSS budget as county cost. For context, this would have increased our 2025 budget request well in excess of 30%. However, the DFD estimate does not take into account the increased administrative burden which accompanies proposed work requirements and the associated processes, mailings, phone calls, sanctions, and the inevitable Fair Hearings when residents face negative actions on their case The complete DFD 21 county forecast is here: DFD Analysis of SNAP Administrative Cost to County. Cost sharing for recipient benefits is still on the table. This proposal would shift benefit costs to the State of New Jersey. Just a 5% cost share to the State of New Jersey would exceed \$96,000,000 per year.

Medicaid - tightening of eligibility standards, semi-annual redeterminations, work requirements for certain recipients, and matching with Federal data to identify potentially ineligible persons.

All of the above will significantly increase the workload and budgetary needs of BCBSS staff.

Alexandra Harwin, Esq. reported from May 1 to May 31, 2025, the agency received Medicaid recoveries in the amount of \$1,247.26, of which BCBSS portion is \$311.82 and the year-to-date 2025 is \$9,656.55, of which BCBSS portion is \$2,414.14. No fraud referrals sent to the Prosecutor's office during the month of May.
